Meeting called to order by Chairman Randy Larson at 8:02AM

- Motion to approve minutes from January (missed at February meeting)
 by Joey, Barry 2nd. None opposed
- Motion to approve February minutes by Dale, Joey 2nd. None opposed.

NRCS Report

- Funding is up in the air due to current government cuts
- No more Inflation Reduction Act
 - Still 6 approved through different funding sources
- CSP deadline March 21st, 2025.
- Matt will be taking Acting Team Lead position for NRCS in Crookston starting April 4th. Unsure duration could be a couple of years. His replacement at the Marshall County office is unknown at this time.

Pheasants Forever Report

- Thief River Watershed Outreach
 - o 105 letters sent, 30 can still go out
 - So far have received 10 letters back from people interested in CRP. 1 of those in Marshall County.
 - o WRE, WRP letters also sent out
- Potential for CRP to landowners along the Mud River

Walk In Access Program (DNR)

- Individuals with a Walk-In Access validation can hunt from September 1 to May 31 during legal hunting hours and open seasons from ½ hour before sunrise to ½ hour after sunset with no landowner contact necessary. Minimum of 40 acres.
- Marshall County SWCD not currently participating. Darren contacted DNR and can start the process in September.
- \$300 kickback from DNR for paperwork

Tree Program

- This year 15,000 trees have been ordered. Another order just placed for 1500
 - o 87 people have placed orders
 - 11 of those want SWCD to plant the trees for them.
- Some varieties are out of stock. Nurseries are running out of stock faster than in the past. Will get a better idea of what we need for 2026 earlier.

- Trees will likely be in the first week of May
- Plantings are about the same from last year. The number of tree orders has increased.

Drill/Tree Program

- Will pick up once the weather starts getting warmer.
- CRP can start in May
 - o 400 acres ready. Trying to stay closer to the Warren area.
